Since 2005, retail alternative assets have grown by 16 percent annually, and nearly half of registered investment advisors are using alternatives to help clients achieve their objectives. The tremendous growth in alternative assets is a result of structural forces, driven by investment outcome needs and as a solution for investors concerns, including interest rate risk, inflation risk, the need for income and protection from tail risk.
